

# TA CHARGING STATION, TA BASIC CHARGING OR TEMPORARY CHARGING

## Report of interest in the procurement of a charging solution

With this form, a resident can report their interest in the procurement of an electric car or plug-in hybrid charging station or temporary charging service. TA cannot guarantee everyone interested with access to a charging station, as the availability of charging stations depends on the capacity of the property's garage, the capacity of the electrical system used by outdoor parking spaces and the number of other residents interested in charging stations at the same location. If a resident can be offered either a TA charging station or a temporary charging service, TA will contact the resident and make a separate agreement with them on the charging solution. If the resident wishes to order a product, a separate binding agreement will be prepared. If the resident's charging needs change during the agreement period, the resident agrees to notify the property manager of their building about this in accordance with the agreement. TA has the right to regularly check the resident's consumption of charging electricity. If the consumption differs substantially from the reported consumption and the resident has not informed TA of this, TA has the right to terminate the charging agreement.
